

INSTALL HARD DISK

Disk Station requires one 3.5" SATA hard disk for installation. Refer to the following steps for details:

Warning! If you use a hard disk with data on it to install, system will format the hard disk and erase all data in some cases. Please back up the data if you need it in the future.

1. Connect the HDD Data Cable and HDD Power Cable to the hard disk. (Not included in the cable-less models.)



2. Place the server horizontally on a desk. The rear panel should be facing you.



3. Push to slide away the upper case.




4. Pull up the upper case.




5. Place the hard disk inside the HDD bay.







6. Fix the hard disk with the 4 HDD screws provided.



7. Connect the HDD Data Cable and HDD Power Cable to the motherboard. (Skip this step if the Disk Station is a cable-less model.)



8. Attach the upper case and slide it back.



9. Fix the case with the 2 case screws provided.




TURN ON SERVER


1. Connect the AC power adapter to the server and plug in the AC power cord to the power outlet.



2. Use the LAN cable to connect the server to your switch/router/hub.



3. Press the power button on the front panel to power up the server. Wait for the POWER LED to be constant blue.


2. Double click on the CD-Rom Drive thumbnail.

Preamble
