It is recommended that you install hard disks with the same size to make the best use of hard disk capacity.


INSTALL HARD DISK

Rack Station requires 3.5" SATA hard drives for installation. Refer to the following steps for details:




Warning! If you use a hard disk with data on it to install, system will format the hard disk and erase all data in some cases. Please back up the data if you need it in the future.


- 1 Push the release button in the direction as indicated below.



- 2 Pull the clip in the direction as indicated below to remove the hard disk tray.




- 3 Attach the prepared SATA hard disk to the hard disk tray and use 4 screws to fix the hard disk. Refer to the picture below for the screw position



INSTALL HARD DISK

- 4 Replace the hard disk tray to the case.



- 5 Push the clip to fix the hard disk tray.




- 6 Repeat the steps above to assemble all hard disks you have prepared.

- 7 Fix the two rack mount kits on both sides with their screws provided.




TURN ON SERVER

- 1 Connect the AC adapter to the power port, and fix the cable to the cable lock. Then plug the power cord into a power socket.



- 2 Connect the RJ-45 cable to the server and connect the other end to your switch/hub/router or notebook/desktop PC.




- 3 Press the power switch to switch the server on.



TURN ON SERVER


- 4 Press the Power button on the front panel to turn on the server.

- 1 Insert the installation CD to your computer.




- 2 Double click on the CD-Rom Drive thumbnail.




- 3 Double click MacOSX.
